08-26-19 **Grand Theft Auto-Arrest** **PV Blvd & Calle Mayor**

At approximately 8:54 PM, officers monitoring radio traffic were notified of an Automated License Plate Reader (A.L.P.R.) hit of a reported stolen vehicle. Officers located the vehicle and conducted a traffic stop. The Driver was arrested for Grand Theft Auto.

08-26-19 **Theft From Vehicle** **1500 Blk Via Arco**
