ARRESTS

12-02-2024 Impaired Driver

2200 BLK PALOS VERDES DR W

At approximately 8:37 PM, an officer was dispatched to a traffic collision and in speaking with one driver, the officer could smell the odor of an unknown alcoholic beverage emitting from their person. An officer conducted a series of field sobriety tests and a preliminary alcohol screening test which registered .168% and .164%. Based on the objective symptoms of intoxication, being involved in an accident, and performance of tests, the driver was arrested for driving under the influence.

12-05-2024 Drugs/Burglary Tools/Identity Theft

1300 BLK PASEO DEL MAR

At approximately 8:55 AM, officers investigated an illegally parked vehicle and contacted the subject in the driver's seat. Officers immediately smelled an odor of burnt marijuana emitting from the vehicle and observed loose marijuana on the driver's side floorboard. A passenger was found to have a firearm and a vehicle search was conducted. Locating a baggy that contained a white powdery substance, the passenger was arrested for carrying a concealed weapon in a vehicle, possession of methamphetamine, possession of a controlled substance while armed, and possession of burglary tools. Also located were ten saw blades and an electronic reciprocating saw, metal hammer, known to be used to commit burglaries and other theft-related crimes. Officers also located a backpack with a US Passport and multiple pieces of mail which did not belong to the driver. The driver was arrested on forgery and identity theft.

12-07-2024 Drugs

300 BLK PALOS VERDES DR W

At approximately 12:48 AM, an officer observed a vehicle code violation and conducted a traffic stop. A California Driver's License and Warrant inquiry revealed the driver had an outstanding felony warrant and was asked to exit the vehicle and consented to a vehicle search. During the vehicle search an officer located a glass pipe with white residue resembling methamphetamine. The driver was arrested for possession of drug paraphernalia and an outstanding felony arrest.

ARRESTS NOT ON PREVIOUS REPORT

11-29-2024 Impaired Driver

2400 BLK PALOS VERDES DR N

At approximately 10:29 PM, an officer observed a vehicle code violation of failure to maintain lighting equipment and conducted a traffic stop. The officer contacted the driver who was slurring their words and could smell the odor of burnt marijuana emitting from inside the vehicle. Officers attempted to conduct standard field sobriety tests but the driver refused to perform them. Also refusing the preliminary alcohol screening test. Based on the physical objective symptoms of intoxication, odor of alcohol/marijuana emitting from the person and slurred speech, the officer arrested the driver for driving under the influence.

Sometime prior to 11-18-24, Unknown Suspect(s) used an unknown tool/item to break a 2nd story window of victim's residence. The suspect(s) then fled undetected.
