ARRESTS

04-22-2025 Traffic Offense/Burglary Tools **2600 BLK VIA RIVERA**

At approximately 11:50 PM, an officer observed a vehicle code violation, conducted a traffic stop and after a search of the vehicle the driver was arrested for possession of burglary tools, providing false identification to a Police Officer, bringing controlled substance into a Jail/Prison and two outstanding warrants. One passenger was arrested for providing false identification to a Police Officer and possession of burglary tools and a second passenger was arrested for possession of burglary tools.
