

RESOLUTION NO.20-12

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, APPROVING THE FY 2020-21 ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017 (SB1) PROPOSED PROJECT LIST FOR THE CITY OF PALOS VERDES ESTATES AND THE AMENDMENT OF THE CITY'S 2020/2021 ADOPTED CAPITAL IMPROVEMENT BUDGET TO REFLECT THESE RMRA FUNDS AND APPROPRIATIONS

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of Palos Verdes Estates are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City of Palos Verdes Estates must adopt by resolution a list of projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City of Palos Verdes Estates, will receive an estimated \$230,223 in RMRA funding in Fiscal Year 2020-21 from SB 1; and

WHEREAS, this is the fourth year in which the City of Palos Verdes Estates is receiving SB 1 funding and will enable the City of Palos Verdes Estates to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the City of Palos Verdes Estates used a Pavement Management System to develop the SB 1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment; and

WHEREAS, the funding from SB 1 will help the City of Palos Verdes Estates maintain and rehabilitate streets and roads throughout the City of Palos Verdes Estates this year and into the future; and


WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the City of Palos Verdes Estates streets and roads are in “Good” condition and this revenue will help us increase the overall quality of our road system and over the next decade will bring our streets and roads into a “Excellent” condition; and

WHEREAS, the SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES HEREBY RESOLVE AS FOLLOWS:


1. Approves the FY2020/21 Road Repair and Accountability Act of 2017 (SB1) Proposed Project List for the City of Palos Verdes Estates (Attachment A).
2. Directs the City’s Finance Director to amend the City’s 2020/2021 Capital Improvement Budget to reflect these RMRA funds and appropriations and create a fund and appropriate moneys as necessary.
3. Directs the City’s Public Works Director to submit the proposed Project List and supporting documentation to the California Transportation Commission by May 1, 2020.
