

RESOLUTION NO. R21-09

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, (1) ACCEPTING AS COMPLETE PW-680-20, THE FY 19/20 MISCELLANEOUS STREET REPAIRS PROJECT; (2) AUTHORIZING THE CITY CLERK TO FILE THE NOTICE OF COMPLETION FOR THIS PROJECT; AND (3) AUTHORIZING THE CITY SUPPORT SERVICES DIRECTOR TO RELEASE THE RETENTION AND MAKE FINAL ACCOUNTING ENTRIES FOR THIS PROJECT.

WHEREAS, on November 10, 2020, the City Council awarded a contract to Onyx Paving Company, Inc. for the completion of the FY 19/20 Miscellaneous Street Repairs Project; and,

WHEREAS, staff has reviewed and inspected the work undertaken pursuant to said contract and has deemed the work to have been completed in accordance with the related plans and specifications; and,

WHEREAS, with the completion of the work under this contract, staff has reviewed the expenditures under the contract with the various available funding sources.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Palos Verdes Estates, California hereby resolves, determines, and orders:

Section 1: the work undertaken by Onyx Paving Company, Inc. under the contract awarded by the City Council for the FY 19/20 Miscellaneous Street Repairs Project (PW-680-20) is hereby accepted as complete; and,

Section 2: the City Clerk is hereby authorized to file a Notice of Completion for this project with the Office of the County Registrar/Recorder; and,

Section 3: the City Support Services Director is hereby authorized to release the retention upon expiration of the 30 day lien period and make final accounting entries for the subject project in Fiscal Year 2020/2021; and,

Section 4: the City Clerk is authorized to certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.


