

RESOLUTION R21-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, (1) RESCINDING R21-19; (2) APPROVING THE PURCHASE OF A REPLACEMENT POLICE ADMINISTRATION VEHICLE IN AN AMOUNT NOT-TO-EXCEED \$35,000; (3) MAKING AN APPROPRIATION OF AB 2766 SUBVENTION FUNDS IN THE AMOUNT OF \$35,000.00; AND (4) AUTHORIZING THE CITY MANAGER TO EXECUTE RELATED DOCUMENTS ON BEHALF OF THE CITY AND THE CITY SUPPORT SERVICES DIRECTOR TO MAKE SUCH ACCOUNTING ENTRIES FOR THIS PURCHASE AS DEEMED APPROPRIATE.

WHEREAS, on May 25, 2021, the City Council considered a report from the Police Chief on the proposed use of AB 2766 Subvention Funds; and

WHEREAS, the Police Chief and City Manager have recommended the use of AB 2766 Subvention Funds to purchase a replacement Police Administration Vehicle (a 2021 Toyota Camry Hybrid) in an amount not-to-exceed \$35,000.

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 1: Resolution R21-19 is hereby rescinded;

Section 2: the purchase of a 2021 Toyota Camry Hybrid vehicle in an amount not-to-exceed \$35,000 is hereby approved and the City Manager is hereby authorized to execute related documents on behalf of the City;

Section 3: an appropriation of AB 2766 Subvention Funds in the amount of \$35,000.00 is hereby approved;

Section 4: the City Support Services Director is hereby authorized to make such accounting entries for this purchase as he deems appropriate; and,


Section 5: the City Clerk is hereby authorized to certify the passage and adoption of this Resolution and enter it into the book of original Resolutions.
