

**RESOLUTION R21-24**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA ACCEPTING THE CITY'S ALLOCATION OF FUNDS FROM THE AMERICAN RESCUE PLAN ACT OF 2021 IN THE AGGREGATE AMOUNT OF \$3,175,184**

**WHEREAS**, the President signed the American Rescue Plan Act of 2021 (ARPA) into law on March 11, 2021; and,

**WHEREAS**, ARPA contains provisions to disburse federal funds to eligible state, local, territorial and Tribal governments, including the City of Palos Verdes Estates; and,

**WHEREAS**, as estimated by the State of California's Department of Finance, the City is eligible for ARPA funding in the aggregate amount of \$3,175,184; and,

**WHEREAS**, disbursement of such funds are subject to acceptance of the funds by the City and, upon acceptance, are scheduled to be disbursed to the City in two payments, each in the estimated amount of \$1,587,592.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Palos Verdes Estates as follows:

Section 1. ARPA funds in the aggregate amount of \$3,175,184 are hereby accepted by the City of Palos Verdes Estates; and,

Section 2. the City Attorney is hereby authorized to review/prepare and the City Manager is hereby authorized to execute on behalf of the City any documents required as part of the acceptance of the ARPA funds; and,

Section 3. the City Support Services Direction is hereby authorized to make such accounting entries as he deems appropriate to properly record this action of the City Council; and,

Section 4. the City Clerk shall certify to the passage and adoption of this Resolution.
