

RESOLUTION R21-34

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, (1) MAKING A SUPPLEMENTAL APPROPRIATION FROM THE SUPPLEMENTAL LAW ENFORCEMENT SERVICES FUND (SLESF)/CITIZEN'S OPTION FOR PUBLIC SAFETY (COPS) FUND IN THE AMOUNT OF \$17,510.00; AND (2) AUTHORIZING THE CITY SUPPORT SERVICES DIRECTOR TO MAKE SUCH ACCOUNTING ENTRIES FOR THIS SUPPLEMENTAL APPROPRIATION AS DEEMED APPROPRIATE.

WHEREAS, on September 14, 2021, the City Council considered a report from the Police Chief on the proposed use of Supplemental Law Enforcement Services Fund (SLESF)/Citizen's Option for Public Safety (COPS) funds; and

WHEREAS, the Police Chief has recommended the use of SLESF (COPS) funds in the amount of \$14,500.00 to finance the cost of the following:

- Vigilant Investigative Platform Subscription (1 year) \$ 7,560.00
(August 2021-July 2022)
- Motorola California RIPA module \$ 9,950.00
Implementation and training


NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 2: the City Support Services Director is hereby authorized to make such accounting entries for this supplemental appropriation as he deems appropriate; and,


Section 3: the City Clerk is hereby authorized to certify the passage and adoption of this Resolution and enter it into the book of original Resolutions.


