

RESOLUTION R21-37

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, (1) MAKING A SUPPLEMENTAL APPROPRIATION FROM THE PROPOSITION C FUND IN THE AMOUNT OF \$25,000.00; AND (2) AUTHORIZING THE CITY SUPPORT SERVICES DIRECTOR TO MAKE SUCH ACCOUNTING ENTRIES FOR THIS SUPPLEMENTAL APPROPRIATION AS DEEMED APPROPRIATE FOR AN UPDATED GEOTECHNICAL REPORT RELATED TO THE PALOS VERDES DRIVE WEST BLUFF COVE SLOPE STABILIZATION PROJECT

WHEREAS, in 2009, in response to slope failures in the Bluff Cove area, the City undertook construction of a retaining structure adjacent to Palos Verdes Drive West; and,

WHEREAS, more recently, the City Engineer reviewed the site with a local geotechnical firm to evaluate the current conditions in the area; and,

WHEREAS, as a result of that review, the City Engineer is recommending additional study of the area; and,

WHEREAS, since Palos Verdes Drive West is a street that carries regularly scheduled, fixed-route public transit services, the proposed geotechnical study is eligible for Proposition C Local Return funding (subject to final approval by METRO).

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 1: a supplemental appropriation from the Proposition C Fund in the amount of \$25,000.00 is hereby approved; and,

Section 2: the City Support Services Director is hereby authorized to make such accounting entries for this supplemental appropriation as he deems appropriate; and,

Section 3: the City Clerk is hereby authorized to certify the passage and adoption of this Resolution and enter it into the book of original Resolutions.




