

**RESOLUTION R21-39**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, (1) MAKING A SUPPLEMENTAL APPROPRIATION FROM THE GENERAL FUND IN THE AMOUNT OF \$18,050.00; AND (2) AUTHORIZING THE CITY SUPPORT SERVICES DIRECTOR TO MAKE SUCH ACCOUNTING ENTRIES FOR THIS SUPPLEMENTAL APPROPRIATION AS DEEMED APPROPRIATE.**

**WHEREAS**, on October 12, 2021, the City Council considered a report from the City Support Services and Development Services on the proposed upgrade for the Code Enforcement Officer to full-time status; and

**WHEREAS**, the staff has recommended an additional appropriation of unassigned general fund resources in the amount of \$18,050.00 to finance the cost of the following:

- Upgrade from a part-time to a full-time Code Enforcement Officer \$ 18,050.00  
(November 2021-June 2022)

**NOW THEREFORE**, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

**Section 1:** a supplemental appropriation from the GENERAL Fund in the amount of \$18,050.00 is hereby approved; and,

**Section 2:** the City Support Services Director is hereby authorized to make such accounting entries for this supplemental appropriation as he deems appropriate; and,


**Section 3:** the City Clerk is hereby authorized to certify the passage and adoption of this Resolution and enter it into the book of original Resolutions.


