

RESOLUTION NO. R22-10

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, ESTABLISHING BUDGETARY AUTHORITY FOR THE USE OF AMERICAN RESCUE PLAN ACT (ARPA) FUNDS FOR FISCAL YEAR 2021-22**

WHEREAS, at a Special Meeting held on June 22, 2021, the City Council adopted Resolution R21-27 adopting the annual budget for Fiscal Year 2021-22; and

WHEREAS, Resolution R21-27 did not include any appropriations related to the use of ARPA funds; and

WHEREAS, the City received \$1,587,592 of ARPA funding in July of 2021, and

WHEREAS, the Secretary of the Treasury has subsequently established a Final Rule for the use of ARPA funds; and

WHEREAS, the City Council at its regular meeting on March 22<sup>nd</sup> 2022 authorized the application of the "Standard Allowance" for the use of ARPA funds; and

WHEREAS, staff has is prepared to execute the transfer of ARPA funds to the General Fund as set forth in Exhibit "A" of this Resolution.


NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, California does hereby RESOLVE, DETERMINE, and ORDER:


