

RESOLUTION R22-44

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, (1) RELEASE AN APPROPRIATION FROM THE UNDESIGNATED PARKLANDS FUND IN THE AMOUNT OF \$200,000; AND (2) AUTHORIZING THE CITY SUPPORT SERVICES DIRECTOR TO MAKE SUCH ACCOUNTING ENTRIES FOR THIS RELEASE OF APPROPRIATION AS DEEMED APPROPRIATE FOR TREE TRIMMING AND LANDSCAPE MAINTENANCE SERVICES IN THE CITY'S PARKLANDS BUDGET IN FY22/23

WHEREAS, the City wishes to amend the current Agreement with Travers Tree Service, Inc, for citywide tree trimming and maintenance services to increase the budgeted amount for tree trimming by an amount of \$156,000 to \$453,000 and increase the budgeted amount for landscape maintenance and fire mitigation efforts in right-of-way corridors by an amount of \$44,000 to \$398,300.



Section 3: The City Clerk is hereby authorized to certify the passage and adoption of this Resolution and enter it into the book of original Resolutions.
