

RESOLUTION NO. R23-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, APPROVING THE PLANS AND SPECIFICATIONS FOR THE FY 21/22 STREET IMPROVEMENT PROJECT ON PASEO DEL MAR (CITY PROJECT NO. PW-692-21), AWARD OF CONSTRUCTION CONTRACT TO HARDY & HARPER, INC., IN THE AMOUNT OF \$1,138,000, AUTHORIZE THE CITY MANAGER TO EXECUTE ALL CONSTRUCTION DOCUMENTS AND APPROVE ADDITIONAL CONSTRUCTION EXPENDITURES NOT TO EXCEED \$114,000, WHICH IS APPROXIMATELY 10% OF THE CONTRACT AMOUNT, AND AUTHORIZE THE CITY CLERK TO RECORD THE NOTICE OF COMPLETION UPON ACCEPTANCE OF THE WORK BY THE PUBLIC WORKS DIRECTOR.

The City Council of the City of Palos Verdes Estates does hereby find and resolve as follows:

SECTION 1: The City Council finds and declares as follows:


- A. Staff recommends the City Council approve the plans and specifications for FY 21/22 Street Improvement Project on Paseo Del Mar (City Project No. PW-692-21); and
- B. Staff recommends to award a City of Palos Verdes Estates contractor agreement to Hardy & Harper, Inc., in the amount of \$1,138,000; and
- C. Staff recommends the City Council authorize the City Manager to execute all contract documents and to approve additional project expenditures not to exceed \$114,000, which is approximately 10% of the contract amount; and
- D. Staff recommends the City Council authorize the City Clerk to record the Notice of Completion upon acceptance of the work by the Public Works Director.

SECTION 2: NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HEMET DOES HEREBY FIND AND RESOLVE TO:

- 1. Approve the plans and specifications for FY 21/22 Street Improvement Project on Paseo Del Mar (City Project No. PW-692-21); and
- 2. Award a City of Palos Verdes Estates contractor agreement to Hardy & Harper, Inc., in the amount of \$1,138,000; and
- 3. Authorize the City Manager to execute all contract documents and to approve additional project expenditures not to exceed \$114,000, which is approximately 10% of the contract amount; and
- 4. Authorize the City Clerk to record the Notice of Completion upon acceptance of the work by the Public Works Director.


