

RESOLUTION NO. R23-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, APPROVING THE PLANS AND SPECIFICATIONS FOR THE FY 22/23 MISCELLANEOUS STREET REPAIRS PROJECT (CITY PROJECT NO. PW-687-22), APPROPRIATE GENERAL FUNDS ASSIGNED FOR CAPITAL PROJECTS IN THE AMOUNT OF \$25,100 TO THE PROJECT, AWARD OF CONSTRUCTION CONTRACT TO ONYX PAVING COMPANY, IN THE AMOUNT OF \$222,000, AUTHORIZE THE CITY MANAGER TO EXECUTE ALL CONSTRUCTION DOCUMENTS AND APPROVE ADDITIONAL CONSTRUCTION EXPENDITURES NOT TO EXCEED \$22,200, WHICH IS APPROXIMATELY 8.6% OF THE CONTRACT AMOUNT, AND AUTHORIZE THE CITY CLERK TO RECORD THE NOTICE OF COMPLETION UPON ACCEPTANCE OF THE WORK BY THE PUBLIC WORKS DIRECTOR.

The City Council of the City of Palos Verdes Estates does hereby find and resolve as follows:

SECTION 1: The City Council finds and declares as follows:

A. Staff recommends the City Council approve the plans and specifications for FY 22/23 Miscellaneous Street Repairs (City Project No. PW-687-22); and

B. Staff recommends that the City Council approve the appropriation of General Funds assigned for Capital Projects in the amount of \$25,100 to the project; and

C. Staff recommends awarding a City of Palos Verdes Estates contractor agreement to Onyx Paving Company, in the amount of \$222,000; and

D. Staff recommends the City Council authorize the City Manager to execute all contract documents and to approve additional project expenditures not to exceed \$19,200, which is approximately 10% of the contract amount; and

E. Staff recommends the City Council authorize the City Clerk to record the Notice of Completion upon acceptance of the work by the Public Works Director.



3. Award a City of Palos Verdes Estates construction contract to Onyx Paving Company in the amount of \$222,000; and
4. Authorize the City Manager to execute all contract documents and to approve additional project expenditures not to exceed \$19,200, which


- is approximately 8.6% of the contract amount; and


