

**RESOLUTION NO. R23-28**

**CONSIDER THE ADOPTION OF A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, AWARDED A CONTRACT WITH WEST COAST ARBORISTS, INC. IN THE AMOUNT OF \$133,500 FOR PREPARATION OF A CITYWIDE TREE INVENTORY AND REPORT; APPROPRIATE \$183,750 IN UNENCUMBERED GENERAL FUND BALANCE (FUND 01); AND AUTHORIZE THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS AND APPROVE ADDITIONAL PROJECT EXPENDITURES NOT TO EXCEED \$20,250, WHICH IS APPROXIMATELY 15% OF THE CONTRACT AMOUNT.**

**WHEREAS**, the City's intent for the Tree Inventory contract is to develop a plan for maintenance needs, tree trimming, and to establish improvement for the overall health of the trees. This includes trees in the public right-of-way, in City parklands, and on all City properties including City Concessions.

The City Council of the City of Palos Verdes Estates does hereby find and resolve as follows:

SECTION 1: The City Council finds and declares as follows:

A. Staff recommends the City Council award a contract with West Coast Arborists, Inc., in the amount of \$133,500 for preparation of a Citywide Tree Inventory and Report; and

B. Staff recommends that the City Council appropriate \$183,750 in unencumbered General Fund Balance (Fund 01); and

C. Staff recommends the City Council authorize the City Manager to execute all Contract Documents and approve additional Project Expenditures not to exceed \$20,250 which is approximately 15% of the contract amount.




