

RESOLUTION R25-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA APPROVING THE SPECIAL TAX REPORT AND SETTING THE PVE LAW ENFORCEMENT SPECIAL TAX LEVY FOR FISCAL YEAR 2025/2026

WHEREAS, the voters of the City of Palos Verdes Estates, at a special election held on April 10, 2018, approved Measure E (codified as Ordinance 18-732), a special tax to fund law enforcement services ("Special Tax") in the city; and,

WHEREAS, Measure E included procedures for determining the rate and method of apportionment of the Special Tax authorized to be levied and enabling the collection and providing for the administration of such tax; and,

WHEREAS, the City Council has caused to be prepared a report entitled "City of Palos Verdes Estates Law Enforcement Services Special Tax Report, Fiscal Year 2025/2026 (the "Special Tax Report"), which is presented by the City Clerk and attached hereto as "Exhibit A"; and,

WHEREAS, the City Council has budgeted and is scheduled to appropriate the revenues from the Special Tax and the expenditures associated with the cost of law enforcement services and administration as part of the City's Fiscal Year 2025/2026 budget.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Palos Verdes Estates as follows:

Section 1. The City Council has duly considered the Special Tax Report, attached hereto as "Exhibit A" and incorporated herein by reference, and hereby approves said report as filed; and,

Section 2. The City Council hereby establishes the tax levy as set forth in the Special Tax Report for the fiscal year commencing July 1, 2025 and ending June 30, 2026; and,


Section 3. The City Council hereby resolves that the proceeds from any funds collected from the Palos Verdes Estates Law Enforcement Special Tax shall be expended for law enforcement services in accordance with Ordinance 18-732; and,

Section 4. The City Council hereby authorizes the Finance Director to file such tax levy with the County of Los Angeles and to take other related actions to ensure the levy and collection of said special tax; and,


