

RESOLUTION R25-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES ADOPTING A COMPREHENSIVE FEE SCHEDULE

WHEREAS, the City Council establishes user and regulatory fees to offset all, or portions of, the costs of providing various services that are of special benefit to applicants or service recipients that are both separate and apart from the general benefit to the public; and

WHEREAS, on January 10, 2018, the City Council adopted Resolution No. R18-04 Adopting a Comprehensive User and Regulatory Fee Study and Adopting a Comprehensive Fee Schedule Establishing and Amending Certain Service and Development-Related Fees for City Services; and

WHEREAS, on May 28, 2019, the City Council adopted Resolution No. R19-15 Adopting a Comprehensive Fee Schedule Establishing and Amending Certain Service and Development-Related Fees for City Services; and

WHEREAS, on July 14, 2020, the City Council adopted Resolution No. R20-23 Adopting a Comprehensive Fee Schedule Establishing and Amending Certain Service and Development-Related Fees for City Services; and

WHEREAS, the City Council hereby finds that the comprehensive user and regulatory fee study and supporting documentation provides adequate evidence to conclude that the revised fees do not exceed the cost to provide the services for which the fees are charged; and

WHEREAS, the City intends to periodically update fees based on direction provided in the comprehensive user and regulatory fee study, as part of the adoption of the existing fees, and feedback received subsequent to update of the City's existing fee schedule; and

WHEREAS, the City Council desires that the City Manager may increase various fees based on the annual percentage change in the all-urban Consumer Price Index for Los Angeles, Long Beach, Anaheim (CPI). If the CPI does not change or goes down in a given year, no change shall be made to the fee schedule that year; and

WHEREAS, prior to adopting adjustments to fees, the City Council shall have the opportunity to review and consider said adjustments; and

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, California hereby resolves as follows:

SECTION 1. Each WHEREAS paragraph, set forth above, is hereby adopted as a specific finding of this City Council.

SECTION 2. The City Council hereby adopts the schedule of fees as set forth in attached Exhibit "A" and incorporated by this reference.

SECTION 3. Annually, various fees in the fee schedule may be updated based on the prior year annual change in the CPI. If the CPI does not change or goes down in a given year, no change shall be made to the fee schedule that year.

SECTION 4. Any and all provisions of prior resolutions of the City Council establishing or modifying fees for the services, programs or products set forth in Exhibit "A" are hereby repealed and replaced as of the effective date of this Resolution in the manner set forth in Exhibit "A"; provided, however, that such repeal shall not excuse or affect the failure of any person or entity to pay any fee heretofore imposed upon such person or entity. The City Council desires to clarify that in adopting this Resolution, it is taking action only on those fees for the services, programs, or products set forth in Exhibit "A" which have been modified from prior resolutions of the City Council. The remaining fees that have not been modified from prior resolutions shall remain in full force and effect.

SECTION 5. This resolution shall become effective August 1, 2025. The fees imposed by this resolution shall go into effect August 1, 2025.


SECTION 6. The City Clerk shall certify to the passage and adoption of this resolution.


