

**RESOLUTION R02-15
RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF PALOS VERDES ESTATES
AUTHORIZING THE SUBMITTAL OF GRANT APPLICATIONS UNDER THE
CALIFORNIA OIL RECYCLING ENHANCEMENT ACT AND THE CALIFORNIA
INTEGRATED WASTE MANAGEMENT ACT**

WHEREAS, the people of the State of California have enacted the California Oil Recycling Enhancement Act that provides funds to cities and counties for establishing and maintaining local used oil collection programs that encourage recycling or appropriate disposal of used oil; and

WHEREAS, the people of the State of California have enacted Assembly Bill 1220 (Eastin, 1993) that provides grants to local governments to establish and implement waste diversion and separation programs to prevent disposal of hazardous waste, including household hazardous waste, in solid waste landfills; and


WHEREAS, the California Integrated Waste Management Board has been delegated the responsibility for the administration of these programs within the state, setting up necessary procedures governing application by cities and counties under these programs; and

WHEREAS, the applicant will enter into an agreement with the State of California for development of the project;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Palos Verdes Estates authorizes the submittal of grant applications to the California Integrated Waste Management Board for all available grants under the California Oil Recycling Enhancement Act and all available Household Hazardous Waste grants under the California Integrated Waste Management Act for the period of Fiscal Year 2002/03 through Fiscal Year 2006/7.

BE IT FURTHER RESOLVED that the City Manager or Public Works Director, or their designee, is hereby authorized and empowered to execute in the name of the City of Palos Verdes Estates all necessary applications, contracts, payment requests, agreements, and amendments hereto for the purposes specified in the grant application.
