

**RESOLUTION NO. R04-25**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PALOS VERDES ESTATES, CALIFORNIA, ADOPTING THE DISASTER  
MITIGATION PLAN.**

WHEREAS, the Disaster Mitigation Act of 2000 requires all government agencies to prepare mitigation plans to minimize the impacts of potential natural disasters; and

WHEREAS, the Federal Emergency Management Agency (FEMA) requires that Disaster Mitigation Plans be approved by November 1, 2004 in order to remain eligible for future mitigation funding from FEMA in the event of a natural disaster; and

WHEREAS, the City desires to comply with these requirements to secure its eligibility for future funding from FEMA; and

WHEREAS, the City is interested in protecting the safety and welfare of its citizens and infrastructure in the event of a natural disaster; and

WHEREAS, the City has prepared a Disaster Mitigation Plan based on the guidelines provided by the Los Angeles County Office of Emergency Management; and

WHEREAS, it is the intention of the City to implement the Disaster Mitigation Plan, as written, herein attached as Exhibit 'A.'

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Palos Verdes Estates, California hereby finds and determines as follows:

Section 1. That the Disaster Mitigation Plan is an important document for the safety and security of the City of Palos Verdes Estates.

Section 2. That the Disaster Mitigation Plan for the City of Palos Verdes Estates is approved and adopted.

Section 3. That the City Clerk shall transmit the Disaster Mitigation Plan to the State of California Office of Emergency Services and the Federal Emergency Management Agency for review and approval.


Section 4. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Records.
