

RESOLUTION R04-33

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA CONSENTING TO AN ELECTION CONSOLIDATION WITH THE CITY OF LOS ANGELES PRIMARY NOMINATING ELECTION TO BE HELD ON TUESDAY MARCH 8, 2005

WHEREAS, a General Municipal Election will be held on Tuesday, March 8, 2005 and has been called by Resolution R04-31 adopted by the City Council of the City of Palos Verdes Estates on October 26, 2004; and

WHEREAS, in accordance with the City of Los Angeles' Resolution, the City Council of the City of Palos Verdes Estates has been requested to consent to a consolidation of the Primary Nominating Election of the City of Los Angeles, including the Los Angeles Community College District, with the City's General Municipal Election scheduled to be held March 8, 2005; and

WHEREAS, the City of Los Angeles agrees to pay its proportionate share of the costs relating to the conduct of this election.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Pursuant to the requirements of the laws of the State of California relating to general law cities, the City Council of the City of Palos Verdes Estates hereby consents to consolidate the Primary Nominating Election of the City of Los Angeles, including the Los Angeles Community College District for the purpose of electing three (3) Members of the Board of Trustees for the Los Angeles Community College District in Districts 2, 4 and 6 with the General Municipal Election of the City of Palos Verdes Estates.

SECTION 2. In the event it appears at a later time that it would be in the best interest of the voters of the City of Palos Verdes Estates to conduct these elections concurrently, instead of by consolidation, then only a verbal agreement between the two City Clerks is required to do so.

SECTION 3. In the event that the General Municipal Election to be held in the City of Palos Verdes Estates should be cancelled due to insufficient candidates, then the City of Los Angeles will be responsible for the conduct of its election within the boundaries of the City of Palos Verdes Estates.

SECTION 4. That in all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.

SECTION 5. That the City Clerk shall forward without delay, a copy of this resolution to the Los Angeles County Board of Supervisors, the Los Angeles County Registrar-Recorder/County Clerk, and to the City Clerk of the City of Los Angeles.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.


