

RESOLUTION R07-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA CREATING AN "HONORARY MEMBER" MEMBERSHIP CATEGORY AND CONFIRMING ALL OTHER FEES, DUES AND CHARGES FOR THE PALOS VERDES BEACH AND ATHLETIC CLUB

WHEREAS, the City has requested that the Palos Verdes Beach and Athletic Club establish a membership category designated as "Honorary Member", which category shall be exempt from payment of an initiation fee; and

WHEREAS, for all other purposes, the "Honorary Member" category shall be subject to all rules of club membership and all fees, dues and charges associated with a resident membership usage;

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, California, hereby resolves as follows:

SECTION 1. Effective July 1, 2007, the dues, fees and charges which may be charged by the Foundation for the Club, shall be as follows:

SECTION 2. The membership category of "Honorary Member" shall only be applicable to the incumbent in the position of the "City Manager" as of July 2, 2007, and shall terminate on the last day of such incumbent's employment with the City.


SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


