

RESOLUTION R07-24

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA AMENDING RESOLUTION R05-21, CITY OF PALOS VERDES PUBLIC SERVICE EMPLOYEES' ASSOCIATION CLASSIFICATION AND SALARY RESOLUTION BY REVISING THE DISBURSEMENT OF THE RETIREE HEALTH BENEFIT.

THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA RESOLVES:

Section 1. Resolution R05-21, "The City of Palos Verdes Public Service Employees' Association Classification and Salary Resolution" is amended by revising Sections 3.1(f) and 5.3 to now read:

The City shall pay a maximum of \$200 per month toward a medical insurance premium to Association members who retire pursuant to a service retirement for "retiree only" coverage after completing twenty (20) years of City service. A retiree may continue on the City's medical insurance plan throughout the tenure of COBRA or obtain medical insurance elsewhere during such period. Thereafter, the retiree shall obtain medical insurance elsewhere. During any time that the retiree obtains medical insurance from a source other than the City's medical insurance, the retiree shall be reimbursed semi-annually, in arrears, upon submittal of proof to City such medical insurance was in effect for the previous six (6) month period. Retiree has the option of adding his or her spouse to the insurance coverage at the time of retirement, which is to be paid entirely by the retired employee. This benefit is available until such time as the retiree is eligible for Medicare benefits.

Section 2. This shall take effect July 1, 2007.

Section 3. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.


