

RESOLUTION R09-09

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PALOS VERDES ESTATES, CALIFORNIA, RECITING THE FACT OF THE
GENERAL MUNICIPAL ELECTION HELD ON MARCH 3, 2009,
DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held and conducted in the City of Palos Verdes Estates, California, on Tuesday, March 3, 2009, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the City Clerk canvassed the returns and has certified the results to the City Council, which are received, attached and made a part hereto as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except absent voter ballots and provisional ballots was 1,370. That the whole number of absent voter ballots cast in the City at City Hall was 1,577, the whole number of provisional and absent voter ballots cast in the precincts was 194, making a total of 3,141 ballots cast in the City.

SECTION 2. That the names of the persons voted for at the election for Member of the City Council are as follows:

George Bird
Sheryl Iannitti
James F. Goodhart

That the name of the person voted for at the election for City Treasurer is as follows:

Joseph C. Sherwood, Jr.

That in accordance with Resolution R08-32, the City conducted a consolidated election on behalf of the City of Los Angeles for the Primary Nominating Election of three (3) members of the Los Angeles Community College District Board of Trustees (Seat #2, #4, #6) and a Special Election for one (1) member of the Los Angeles Community College District Board of Trustees (Seat #7).

SECTION 3. That the number of votes given at each precinct and the number of votes in the City given to each of the persons above named for the respective offices for which the persons were candidates were as listed in "Exhibit A" attached and were as listed in "Exhibit B" attached for the Primary Nominating and Special Election for the Los Angeles Community College District Board of Trustees.

SECTION 4. The City Council does declare and determine that James F. Goodhart and George Bird are elected as "Member of the City Council" for the full term of four years and that Joseph C. Sherwood, Jr. is elected as "City Treasurer" for the full term of four years.


SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the results of election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person, and (5) the total number of votes given to each person.

SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.


SECTION 7. A copy of this resolution and the statement of the results of election for the Los Angeles Community College District Board of Trustee Offices shall be transmitted to the City Clerk's Office, City of Los Angeles.

SECTION 8. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.




