**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, AMENDING THE BAIL SCHEDULE TO REFLECT CIVIL PENALTY INCREASE FOR PARKING CITATIONS EFFECTIVE SEPTEMBER 1, 2010**

**WHEREAS**, the Office of the City Manager of the City has reviewed the fee schedule and made certain recommendations to the City Council; and

**WHEREAS**, it is equitable that the City of Palos Verdes Estates be compensated for providing such direct services; and


**WHEREAS**, the City of Palos Verdes Estates has certain fees established including parking citation rates for violation of parking regulations; and

**WHEREAS**, the fines established in March of 2009 for parking fines in the City of Palos Verdes Estates are consistently lower than the surrounding jurisdictions.


**NOW, THEREFORE, BE IS RESOLVED** by the City Council of the City of Palos Verdes Estates as follows:
