

RESOLUTION R12-22

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES
ESTATES, CALIFORNIA APPROVING MONTHLY BOARDING RATES
AND OTHER FEES AND CHARGES FOR THE PALOS VERDES STABLE
EFFECTIVE OCTOBER 1, 2012 AND RESCINDING RESOLUTION R11-16**

WHEREAS, the Concession Agreement dated January 27, 2009 with HGS Management LLC, serving as Concessionaire for operation of the Palos Verdes Stable, provides that the fees and charges imposed by the Concessionaire in connection with the Palos Verdes Stable shall be approved by Resolution of the Palos Verdes Estates City Council; and

WHEREAS, HGS has requested an increase in the monthly boarding rates for certain stall types and a decrease in the rate charged for "Substitute Special Hay" with all other fees and charges to remain unchanged,

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, California hereby resolves as follows:

SECTION 1. Effective October 1, 2012, the boarding fees and service fees which may be charged by HGS Management LLC as the Palos Verdes Stables Concessionaire shall be as follows:

All Stalls include feeding twice per day (up to four flakes), cleaning twice per day, and bedding as needed.

Three Days per Week	\$ 75 per Month
Four Days per Week	\$100 per Month
Five Days per Week	\$125 per Month



SECTION 2. The boarding rates and services fees for the Palos Verdes Stable as set forth in Resolution R11-16 are hereby rescinded.


SECTION 3. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.




