**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES APPROVING THE ADOPTION OF A YOUTH EMPLOYMENT PLAN FOR THE REGIONAL PARK AND OPEN SPACE DISTRICT EXCESS FUNDS GRANT PROGRAM FOR TREE PLANTING, PERGOLA LIGHTING, GEORGE ALLEN FIELD BLEACHERS, AND PEDESTRIAN PATHWAYS PROJECTS**

WHEREAS, the people of the County of Los Angeles on November 3, 1992, and on November 5, 1996, enacted Los Angeles County Proposition A, Safe Neighborhood Parks, Gang Prevention, Tree Planting, Senior and Youth Recreation, Beaches and Wildlife Protection (the propositions), which, among other uses, provides funds to public agencies and nonprofit organizations in the County for the purposes of acquiring and/or developing facilities and open space for public recreation; and

WHEREAS, the Propositions also created the Los Angeles County Regional Park and Open Space District (the District) to administer said funds; and

WHEREAS, the District's procedures require the Applicant to adopt, by resolution, a Youth Employment Plan at a duly noticed public meeting; and

WHEREAS, the Applicant certifies, through this resolution, that the attached Youth Employment Plan is approved for submission to the District; and


**NOW THEREFORE BE IT RESOLVED** that the City Council of the City of Palos Verdes Estates, California hereby:

### **TREE PLANTING, PERGOLA LIGHTING, GEORGE ALLEN FIELD BLEACHERS, AND PEDESTRIAN PATHWAYS PROJECTS GRANT**

**Grant No. 58G8-12-2274**

#### **Background:**

The City of Palos Verdes Estates received funds pursuant to the Safe Neighborhood Park Propositions (Proposition A) of 1992 and 1996 to fund the above named project. The project includes Tree Planting, Pergola Lighting, George Allen Field Bleachers, and Pedestrian Pathways.

#### **Tasks That May Be Performed by At-Risk Youth:**

The nature of these projects requires skilled laborers; therefore, youth will not perform any part of this project. Youth will be used for maintenance after completion of the projects.

#### **Method of Youth Employment:**

The City hires part-time students each summer to perform maintenance around the City and they will be directed to maintain these areas as well as others.

#### **Youth Employment Goal:**

The City's Youth Employment Goal for the City of Palos Verdes Estates is \$17,190.60. The City has met and exceeded this goal.
