

RESOLUTION NO. R13-09

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES
ESTATES APPOINTING DANIEL DREILING AS INTERIM CITY MANAGER
PER GOVERNMENT CODE SECTION 21221(h)**

WHEREAS, the City of Palos Verdes Estates is currently engaged in recruiting for a qualified permanent City Manager due to the resignation of the current City Manager;

WHEREAS, Dreiling, who previously served the City as Police Chief, possesses a comprehensive understanding of the City organization and the community, has specialized skills and knowledge crucial to the continued successful operation of the City;

WHEREAS, the City would like to retain Dreiling's services as Interim City Manager to allow the Palos Verdes Estates sufficient time to obtain a qualified replacement;


WHEREAS, Dreiling possesses necessary and specialized skills to represent Palos Verdes Estates during this time of transition, and to prevent stoppage of that vital public service; and,

WHEREAS, the City Council desires to appoint Dreiling to the position of Interim City Manager under Government Code section 21221(h), an appointment deemed to be for interim purposes and requiring specialized skills, effective February 23, 2013 and for a period not to exceed twelve (12) months, and subject to a limit of 960 hours for all CalPERS employers in a fiscal year. The compensation of Dreiling shall not exceed the maximum published pay schedule for the vacant position of City Manager.

THEREFORE, BE IT RESOLVED by the City Council of the City of Palos Verdes Estates that Daniel Dreiling is hereby appointed Interim City Manager, effective February 23, 2013 for a period not to exceed twelve (12) months, but ending not later than May 15, 2013 based on the terms described in the Interim City Manager Employment Agreement dated February 23, 2013.






