

**RESOLUTION R13-31**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PALOS VERDES ESTATES, CALIFORNIA  
APPROVING THE USE OF AB2766 FUNDS (CLEAN AIR FUNDS) AND ADJUSTING  
FY 2013-14 BUDGET**

WHEREAS, on October 22, 2013, the City Council considered a report from the Police Chief on the proposed use of AB2766 Funds (Clean Air Funds); and

WHEREAS, the Police Chief has recommended the use of AB2766 Funds in the amount of approximately \$30,000 to purchase a new Honda Civic Hybrid automobile for the Police Department; and

WHEREAS, no further comment was received from the public regarding the use of the funds.

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 1. To adjust the Budget for FY 2013-14 (#3) as follows:

Section 2. The remaining balance of approximately \$90,000 of the original \$120,000 remain available for use by the City for future acquisitions that comply with the guidelines set forth under AB2766 in an effort to reduce air pollution from motor vehicles.

Section 3. The City Clerk shall certify to the passage and adoption of Resolution R13-31.


