

RESOLUTION R14-22
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES
ESTATES, CALIFORNIA APPROVING AN INCREASE IN MONTHLY DUES,
CONFIRMING OTHER EXISTING FEES, DUES AND CHARGES FOR THE PALOS
VERDES BEACH AND ATHLETIC CLUB AND RESCINDING RESOLUTION R11-10

WHEREAS, the Concession Agreement dated September 9, 2008 provides that the the fees, dues and charges which can be imposed by the Foundation in connection with the Club shall be approved by resolution of the City Council; and

WHEREAS, the Foundation has requested an increase in all categories of monthly dues in the amount of \$20 per month effective July 1, 2014 with all other fees and charges to remain at the current rate,

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, Caliofrniation hereby resolves as follows:


