WHEREAS, on November 25, 2014, the City Council considered a report from the Police Chief on the proposed appropriation and use of existing available and FY 14-15 COPS funds; and

WHEREAS, the Police Chief has recommended the appropriation and use of additional COPS funds in the amount of \$69,000 to finance a Police Department Security Camera System and that the balance of the funds remain unobligated for future capital equipment, as needed; and

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:


Section 1. The anticipated FY 2014-15 COPS allocation of \$100,000, in the amounts needed, as well as existing available COPS Fund balance will be used to purchase the aforementioned camera system:

Section 2. The City Clerk shall certify to the passage and adoption of this Resolution.




