

RESOLUTION R15-02

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF PALOS VERDES ESTATES, CALIFORNIA
APPROVING THE SEWER SYSTEM MANAGEMENT PLAN
5-YEAR UPDATE AND RECERTIFICATION**

WHEREAS, the State Water Resources Control Board (SWRCB) adopted Statewide General Waste Discharge Requirements (GWDR) for publicly owned sanitary sewer systems requiring owners or operators of a qualifying sewer system to have their SSMP approved and recertified every five years or whenever there is significant change in the document and;

WHEREAS, the City Council deem it appropriate for the cost of such services to be borne by the users and beneficiaries thereof; and

WHEREAS, the City of Palos Verdes Estates finds that the Sewer System Management Plan has been completed and must be approved on January 14, 2015; and

WHEREAS, the Sewer System Management Plan shall be periodically reviewed at least once every five years, and the City shall make any amendments or changes to its Plan;

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The Sewer System Management Plan is approved in accordance with State Water Resources Control Board Order No. 2006-0003-DWQ Statewide General Waste Discharge Requirements (GWDR) for Sanitary Sewer Systems.

Section 2. The Planning & Building Director is authorized to certify the completion of the SSMP to the State Water Resources Control Board.

Section 3. The City Clerk shall certify to the adoption of Resolution R15-02 and enter it into the book of original resolutions.




