

RESOLUTION R15-08

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PALOS VERDES ESTATES, CALIFORNIA
CHANGING THE DOG LICENSING FEES**

WHEREAS, the City entered into an agreement with Los Angeles County Department of Animal Care and Control to include administration of the licensing of animals effective July 2013; and renewed a municipal services agreement in November 2014;

WHEREAS, the City has not adjusted regular fees for dog licenses since 1991 and established a rate for service/guide dogs in 2003; and

WHEREAS, in accordance with Chapter 6.08 of the Palos Verdes Estates Municipal Code all licensing fees shall be established by Resolution; and

WHEREAS, the City Council held a noticed public hearing on February 10, 2015 to discuss changes in dog licensing fees; and

WHEREAS, the City Council wishes to reaffirm the regular fees established for the licensing of dogs; and

WHEREAS, the City Council wishes to adjust the fees of licensing of dogs to provide a discounted rate for senior residents of sixty (60) years of age or older for altered dogs, and for all service dogs.

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES FIND AND RESOLVE AS FOLLOWS:

SECTION 1.

**ANIMAL LICENSE FEE SCHEDULE – ANNUAL RATES
(effective February 10, 2015)**

ALTERED DOG	\$12.00
UNALTERED DOG	\$24.00
SENIOR-OWNED ALTERED DOG (60 years of age or older)	\$ 7.50
SERVICE DOG	\$ 5.00
ALTERED CAT (optional/not required)	\$ 5.00
UNALTERED CAT (optional/not required)	\$10.00
DELINQUENCY CHARGE (after 60 days)	\$10.00


SECTION 2.

All resolutions previously adopted by the City Council as they pertain to license fees for dogs are hereby rescinded.

SECTION 3.

The City Clerk shall certify the passage and adoption of Resolution R15-08.




