

RESOLUTION R15-30

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PALOS VERDES ESTATES, CALIFORNIA APPROVING PROGRAM FEES AND
CONFIRMING MONTHLY BOARDING RATES AND OTHER EXISTING FEES AND
CHARGES FOR THE PALOS VERDES STABLE**

WHEREAS, the Concession Agreement dated January 27, 2009, with HGS Management LLC, serving as Concessionaire for operation of the Palos Verdes Stable, provides that the fees and program charges imposed by the Concessionaire in connection with the Palos Verdes Stable shall be approved by Resolution of the Palos Verdes Estates City Council; and

WHEREAS, the City desires to codify, along with boarding and boarding related service fees, the inclusion of all program fees (lessons, camps, etc.) as called for in section 7A of the concession agreement.

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, California hereby resolves as follows:

SECTION 1. Effective with adoption of this Resolution, the currently affirmed and authorized boarding fees and service fees charged by HGS Management LLC as the Stables Concessionaire are as follows:

Effective September 1, 2015, certain boarding fees and service fees that are charged by HGS Management LLC may be modified to not exceed the following rates providing any incremental changes to the current rates up to the authorized amount are consistent with, establish and are based on the following proportionate distinctions between residents and non-residents.
