

RESOLUTION R15-31

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA AUTHORIZING THE DEDUCTION OF ASSOCIATION DUES FROM THE SALARIES OF CITY EMPLOYEES WHO ARE MEMBERS OF THE PALOS VERDES ESTATES PUBLIC SERVICE EMPLOYEES ASSOCIATION.

WHEREAS, the representatives of the City of Palos Verdes Estates (the “City”) and the Palos Verdes Estates Public Service Employees Association (the “Association”) have met and conferred in accordance with the Meyers Miliias Brown Act (Government Code section 3500 et seq.);

WHEREAS, the Association has requested that the City deduct Association dues from the pay of its members who so authorize, and remit the amounts withheld to the Association;

WHEREAS, Government Code sections 1157.1, 1157.3, and 3508.5 provide that employees of a public agency may authorize such withholdings on approval of and in accordance with the provisions made by the governing body of the public agency;

WHEREAS, the Association has requested that, for each member who authorizes such withholdings, an amount specified by the Association be withheld per pay period and subject to change in accordance with the rules and procedures of the Association.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES DOES RESOLVE, DECLARE, AND DETERMINE AS FOLLOWS:

SECTION 1: AUTHORIZATION

Upon the receipt of a signed written authorization from an employee for deduction of Association dues, the City is hereby authorized to withhold such dues and deductions from the salary of the employee and to remit the withholdings to the Association in a timely manner according to written instructions of the Association President.

SECTION 2: REVOCATION OF AUTHORIZATION

The City is hereby authorized to continue to withhold the above deductions unless the employee files a signed written revocation of authorization for the continued withholding of the deductions.

SECTION 3: DEDUCTIONS

For each employee who requests and authorizes the above deductions, the amount to be withheld from the employee’s salary, and the amount to be remitted to the Association, shall

be done per pay period. The amount of the deduction shall be subject to change no more than once per calendar year upon receipt by the City of written correspondence from the Association President requesting a change in the amount of the withholding and affirming that affected employees have been provided written notice of the change.

SECTION 4. CERTIFICATION

The City Clerk shall certify to the passage and adoption of this resolution.
