

RESOLUTION R15-47

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES
ESTATES, CALIFORNIA ADOPTING NEW AND REVISED FEES FOR
SERVICES RENDERED RELATING TO PLANNING, ENGINEERING AND
THE OFFICE OF THE CITY CLERK**

WHEREAS, The City of Palos Verdes Estates (“City”) is empowered to impose reasonable fees, rates, and charges for municipal services. California Government Code Section 66000 et seq. authorizes the City to adopt fees for municipal services, provided such fees do not exceed the reasonable cost to the City for providing the services. Periodically, the City Council determines that fees, rates, and charges should cover the costs reasonably borne or a substantial portion of the actual costs of the goods and services provided by the City.

WHEREAS, the City has conducted an extensive analysis of its services, the costs reasonably borne by the City in providing its services, the beneficiaries of such services, and the revenues produced by those paying fees and charges for such services. City departments have reviewed the fee schedule and made certain recommendations.

WHEREAS, the adoption of this Resolution approves and sets forth a procedure for increasing reasonable costs, fines and penalties for the purpose of meeting increased operating expenses of City departments and is, therefore, exempt from the California Environmental Quality Act (Public Resources Code Sections 21080 et seq.) pursuant to Public Resources Code Section 21080(b)(8)(A).

WHEREAS, the City staff has undertaken a review and analysis of the cost of providing such service which has been received and considered by the City Council and on which was held a duly noticed public hearing as required by law:

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Based upon the foregoing, the City Council hereby establishes the fees, rates and charges for the items identified in the following table:

Section 2. The City Council hereby retains in its entirety the previously imposed fees and charges as contained in Resolution R10-01 except the following fee for service is hereby repealed:

Section 3. The City Council hereby finds and determines that the fees established by this resolution do not exceed the estimated cost of providing service for which the fee is imposed.

Section 4. This resolution shall become effective sixty (60) days after its adoption. The City Clerk shall certify to the adoption of Resolution R15-47.


