

RESOLUTION R16-16

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PALOS VERDES ESTATES, CALIFORNIA
APPROVING THE USE OF FY14-15 COPS FUNDS**

WHEREAS, on May 24, 2016, the City Council considered a report from the Police Chief on the proposed use of additional FY14-15 COPS funds; and

WHEREAS, the Police Chief has recommended the use of additional COPS funds in the amount of \$4,140 to finance the completion of a previously approved Firing Range Project (R14-10);

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 1. The current COPS fund balance is \$186,000, which includes unobligated funds from FY14-15 and FY15-16. For this project, FY14-15 COPS funds* will be used to fund the completion of the following:

Modify Range Lighting & Install Storage Cabinets	\$5,000	Approved (R14-10)
Range Training Equipment (Scenario Training)	\$5,000	Approved (R14-10)
Additional amount requested to complete the project	<u>\$4,140*</u>	<u>(R16-16)</u>
Total Cost	\$14,140	


The prior approved amount of \$10,000 (R14-10) will come from COPS funds from FY13-14. All remaining funds shall be available for future needs of the Police Department as recommended by the Police Chief and approved by the City Council.

Section 2. The City Clerk shall certify to the passage and adoption of Resolution R16-16.


