

RESOLUTION R17-13

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
PALOS VERDES ESTATES, CALIFORNIA, RECITING THE FACT OF THE
GENERAL MUNICIPAL ELECTION HELD ON MARCH 7, 2017,
DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held and conducted in the City of Palos Verdes Estates, California, on Tuesday, March 7, 2017, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns and has certified the results to the City Council, which are received, attached and made a part hereto as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except vote-by-mail ballots and provisional ballots was 1,550. That the whole number of vote-by-mail ballots cast in the City was 2292, making a total of 3,842 ballots cast in the City.

SECTION 2. That the names of the persons voted for at the election for Member of the City Council, in order as they appeared on the official ballot, are as follows:

Jim Goodhart
Sanford S. Davidson
Kenneth J. Kao

That the name of the persons voted for at the election for City Treasurer, in order as they appeared on the official ballot, are as follows:

John Rea
Jim Nyman
Victoria A. Lozzi

That the measure voted upon at the election (Measure D) is as follows:

"Shall an ordinance be adopted that continues a levy of the existing special tax for a period of twelve (12) years on each eligible parcel in the City at the initial base rate of \$342.34 plus \$0.196073 per square foot of building improvement effective July

1, 2017, and maintains the existing 6.2% limit on annual adjustments, initially generating approximately \$4.7 million annually to finance fire suppression and paramedic services?”

SECTION 3. That the number of votes given at each precinct and the number of votes in the City given to each of the persons above named for the respective offices for which the persons were candidates, and for and against measure (Measure D) were as listed in “Exhibit A” attached.

SECTION 4. The City Council does declare and determine that Kenneth J. Kao and Sanford S. Davidson are elected as “Member of the City Council” for the term of three years and eight months; that Victoria A. Lozzi is elected as “City Treasurer” for the term of three years and eight months.

That as a result of the election, two-thirds of the voters voting on the measure relating to continuance of a levy of the existing special tax to finance fire suppression and paramedic services for a period of twelve years did not vote in favor of it, and that the measure was not carried, and shall not be deemed adopted and ratified.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the results of election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person, (5) the total number of votes given to each person; and for and against each measure; and (6) The total number of votes given to each person, and for and against each measure.


SECTION 6. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 7. The City Clerk shall certify to the passage and adoption of this resolution.


