

**RESOLUTION R18-39**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PALOS VERDES ESTATES, CALIFORNIA  
APPROVING THE USE OF COPS FUNDS**

WHEREAS, on July 24, 2018, the City Council considered a report from the Police Chief on the proposed use of COPS funds; and

WHEREAS, the Police Chief has recommended the use of COPS funds in the amount of \$65,000 to finance the cost of the following:

ALPR Invest. Data Platform Subscription (2 years)	\$ 14,000.00
Tasers and associated equipment (11)	\$ 16,000.00
Portable Radios 10 (refurb.)	\$ 7,500.00
Cell Hawk-Annual Subscription (2 years)	\$ 5,000.00
Advanced Medical Packs and Training OT	\$ 15,000.00
South Bay Mutual Aid Training OT	<u>\$ 7,500.00</u>
Total	\$ 65,000.00

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 1. The current COPS fund balance is \$335,447.57, which includes unobligated funds from FY16-17 and FY17-18. For this project, FY16-17 COPS funds will be used to fund the following:

South Bay Mutual Aid Training OT	<u>\$ 7,500.00</u>


