

**RESOLUTION R18-49**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
PALOS VERDES ESTATES, CALIFORNIA  
APPROVING THE USE OF COPS FUNDS**

WHEREAS, on November 13, 2018, the City Council considered a report from the Police Chief on the proposed use of COPS funds; and

WHEREAS, the Police Chief has recommended the use of COPS funds in the amount of \$5,750.00 to finance the cost of the following:

Nixle 360 (1-year subscription)

- Reverse 911 and enhanced community notification platform/subscription

Section 1. The current COPS fund balance is ~\$210,000, which includes unobligated funds from FY16-17 and FY17-18. For this project, FY16-17 COPS funds will be used to fund the following:



Section 2. The City Clerk shall certify to the passage and adoption of Resolution R18-49.


