

RESOLUTION R19-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA APPROVING THE USE OF COPS FUNDS

WHEREAS, on April 9, 2019, the City Council considered a report from the Police Chief on the proposed use of COPS funds; and

WHEREAS, the Police Chief has recommended the use of COPS funds in the amount of \$16,255.25 to finance the cost of the following:

Everbridge Multi-Jurisdictional Notification System (MJNS). Area G-Pilot Program (3-year subscription).

- Reverse 911 and enhanced community notification platform/subscription Cost \$16,255.25

NOW THEREFORE, the City Council of the City of Palos Verdes Estates DOES RESOLVE AS FOLLOWS:

Section 1. The current COPS fund balance is \$478,489, which includes unobligated funds from FY16-17 and FY17-18. For this project, FY16-17 COPS funds will be used to fund the following:

Everbridge Multi-Jurisdictional Notification System (MJNS). Area G-Pilot Program (3-year subscription).

- Reverse 911 and enhanced community notification platform/subscription Cost \$16,255.25

To authorize the adjustment of the FY 2018-19 Budget as follows:

Table with 5 columns: Fund, Dept., Object, Description, Amount. Row 1: 05, 4000, 63310, Safety Equipment, \$16,255.25. Row 2: 05, , 25310, Budgeted Fund Balance, (\$16,255.25).

The prior approved amount of \$16,255.25 (R19-11) will come from COPS funds from FY16-17. All remaining funds shall be available for future needs of the Police Department as recommended by the Police Chief and approved by the City Council.

Section 2. The City Clerk shall certify to the passage and adoption of Resolution R19-11.
