

RESOLUTION R19-02

**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF PALOS VERDES ESTATES, CALIFORNIA,
PARTIALLY DELEGATING THE POWER TO CONDUCT WEED ABATEMENT
TO THE CONSOLIDATED FIRE PROTECTION DISTRICT
OF LOS ANGELES COUNTY**

WHEREAS, the City of Palos Verdes Estates joined the Consolidated Fire Protection District of Los Angeles County ("District"); and

WHEREAS, when joining the District, by contract, the City acknowledged the right of the District to impose fire suppression assessments to cover the cost of its activities, including weed abatement; and

WHEREAS, although the City is part of the District, the City retains the power and authority to conduct its own weed abatement pursuant to its general police powers and under specific statutory authority; and

WHEREAS, the City Council wishes hereby to permit the District to conduct parcel-by- parcel weed abatement within the City and wishes to ensure that the City's own weed abatement does not conflict with the District's activities.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES AS FOLLOWS:

SECTION 1. DELEGATION. The Consolidated Fire Protection District of Los Angeles County is hereby authorized to conduct parcel-by-parcel weed abatement, including cost recovery, in the City of Palos Verdes Estates.

SECTION 2. AUTHORIZATION TO COORDINATE. The City Council authorizes the City Manager, and other City staff members as designated by the City Manager, to coordinate with the Consolidated Fire Protection District of Los Angeles County to ensure that the City's own weed abatement does not conflict with that of the District.

SECTION 3. The Mayor shall sign this Resolution and the City Clerk shall attest thereto, and thereafter this Resolution shall take effect and be in force.


