**A RESOLUTION OF THE CITY COUNCIL OF

APPROVING THE EXECUTION OF PROGRAM SUPPLEMENT
AGREEMENTS NO. 004 AND NO. 005 TO LOCAL AGENCY-STATE
AGREEMENT NO. SLTPP-5283**

WHEREAS, on August 10, 1993, the City Council of the City of Palos Verdes Estates approved participation of the city of Palos Verdes Estates in the State-Local Transportation Partnership Program, pursuant to Streets and Highways Code Sections 2600 et seq. (the "Program");


WHEREAS, the Program is carried out by the State of California Department of Transportation Office of Local Programs through State-Local Entity Master Agreement No. SLTPP-07-5283 (the "Master Agreement"), and Program Supplement No. 001 which was approved by the City Council on September 26, 1995, and Program Supplement No. 002 which was approved by the City Council on November 14, 1995; and

WHEREAS, the State of California Department of Transportation Office of Local Programs through Supplement Agreement No. 004 covers Project Number SB99-5283(001), Palos Verdes Drive West from Paseo Del Mar to Yarmouth Road and Supplement Agreement No. 005 covers Various Locations (Nine Streets);

NOW, THEREFORE, THE CITY COUNCIL OF PALOS VERDES ESTATES, CALIFORNIA, DOES RESOLVE AS FOLLOWS:


- Section 1. Supplement Agreements No. 004 and No. 005 are hereby approved.


