**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, ADOPTING THE 2025 CITYWIDE SEWER MASTER PLAN (SMP) UPDATE**

WHEREAS, the City of Palos Verdes Estates owns and is responsible for ensuring system design, adequate sizing, and maintainability; and

WHEREAS, the City's last Sewer Master Plan (SMP) was adopted in 2002, and significant changes in land use, population, regulatory requirements, and system conditions have occurred since that time; and

WHEREAS, on July 9, 2024, the City authorized an agreement with Psomas to perform the Citywide Sewer Master Plan (SMP) Update (Resolution 24-37); and

WHEREAS, the City initiated a comprehensive update to the Sewer Master Plan to evaluate current system capacity and condition, identify existing and future deficiencies, recommend capital improvement projects, and enhance system management through the integration of Geographic Information System (GIS) data; and

WHEREAS, the City of Palos Verdes Estates has determined the Citywide SMP Update is not a project as defined by the California Environmental Quality Act ("CEQA") (CEQA Guidelines Section 15378).

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates does hereby FIND AND RESOLVE TO,

1. Adoption of the 2025 Citywide Sewer Master Plan Update as the guiding document for planning, maintaining and approving the City's sanitary sewer system.
