

RESOLUTION NO. R25-35

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, APPROPRIATING UNENCUMBERED GENERAL FUND (FUND 01) IN THE AMOUNT OF \$150,000 TO INCREASE THE TREE TRIMMING AND MAINTENANCE CONTRACT WITH TRAVERS TREE SERVICE, INC. FROM \$200,000 TO \$350,000

WHEREAS, at a Regular Meeting held on June 24, 2025, the City of Palos Verdes City Council adopted Resolution R25-21 adopting the annual budget for Fiscal Year 2025-2026;

WHEREAS, the City wishes to amend the current Agreement with Travers Tree Service, Inc., for citywide tree trimming and maintenance services to increase the budgeted amount for trimming by an amount of \$200,000 to \$350,000;

WHEREAS, the funding for tree trimming and maintenance services is available within the General Fund; and

WHEREAS, staff has identified a provider for these services.

NOW, THEREFORE, the City Council of the City of Palos Verdes Estates, California does hereby RESOLVE, DETERMINE, and ORDER:

SECTION 1: The budget adjustments as set forth in Exhibit "A" hereof are hereby approved; and


SECTION 2: The City Clerk is hereby authorized to certify the passage and adoption of this Resolution and enter it into the book of original Resolutions.


