

RESOLUTION NO. R26-06

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES, CALIFORNIA, AWARD A ONE-YEAR CONTRACT (BASE) WITH THE OPTION OF FOUR, ONE-YEAR EXTENSIONS TO FIRE GRAZERS, INC. FOR CITYWIDE FIRE SAFETY WEED ABATEMENT – GOAT GRAZING SERVICES IN THE AMOUNT OF \$218,525.46; APPROVE ADDITIONAL EXPENDITURES NOT TO EXCEED 5% OF THE ANNUAL CONTRACT AMOUNT, WHICH IS APPROXIMATELY \$10,927, FOR A POSSIBLE COMPLETION BONUS; AUTHORIZE A BUDGET ADJUSTMENT FOR FY2025/26 CITYWIDE FIRE SAFETY WEED ABATEMENT PROGRAM OPERATING BUDGET IN THE AMOUNT OF \$150,158.20 TO FUND THE GOAT GRAZING SERVICES CONTRACT; AND AUTHORIZE THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS IN FINAL FORM AND FORMAT AS APPROVED BY THE CITY ATTORNEY

WHEREAS, portions of the City are located in a Very High Fire Hazard Severity Zone, which requires the City to clear weeds and brush within the City rights-of-way, City parklands and open space to create fire breaks adjacent to developed property/structures on an annual basis; and,

WHEREAS, the City's intent for the fire safety weed abatement contract requires weed abatement clearance to be performed within twelve (12) goat grazing weed abatement areas shown on Exhibit "A" attached hereto and other areas within the scope of these services as may be determined by the Public Works Director.

WHEREAS, the City wishes to increase the budgeted amount for Citywide Fire Safety Weed Abatement Program Operating budget by an amount of \$150,158.20 from \$766,600 to \$916,758.20 for FY2025/26.

The City Council of the City of Palos Verdes Estates does hereby find and resolve as follows:

SECTION 1: THE CITY COUNCIL FINDS AND DECLARES AS FOLLOWS:

- A. Staff recommends the City Council award a one-year (1) contract (base) with the option of four (4), one-year extensions to Fire Grazers, Inc. for Citywide Fire Safety Weed Abatement – Goat Grazing Services in the amount of two hundred eighteen thousand five hundred twenty five dollars and forty six cents (\$218,525.46).

SECTION 2: NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PALOS VERDES ESTATES DOES HEREBY FIND AND RESOLVE TO:


1. Award a one-year contract with the option of four (4), one-year extensions to Fire Grazers, Inc. for Citywide Fire Safety Weed Abatement – Goat Grazing Services in the amount of two hundred eighteen thousand five hundred twenty five dollars and forty six cents (\$218,525.46); and
2. Approve additional expenditures not to exceed 5% of the annual contract

amount, which is approximately \$10,927, for a possible completion bonus;

3. Authorize a budget adjustment for FY2025/26 Citywide Fire Safety Weed Abatement Program Operating Budget in the amount of \$150,158.20 to fund the goat grazing services contract; and
4. Authorize the City Manager to execute all contract documents in final form and format as approved by the City Attorney.


