#### ARRESTS

**04-06-2026 Possession of Nitrous Oxide Arrest VIA DEL MONTE & PASEO DEL SOL**

At approximately 2:30 AM, officers observed a vehicle parked and began an investigation. The driver was subsequently arrested for possession of nitrous oxide.

**04-06-2026 Drug Arrest PALOS VERDES DR W & VIA CORTA**

At approximately 5:15 AM, officers conducted a traffic stop and began an investigation. The officers located property that did not belong to the occupants. The driver and passenger were subsequently arrested for possession of a controlled substance, drug paraphernalia, nitrous oxide, and misappropriation of found property.

At approximately 2:40 AM, officers attempted to conduct a traffic stop, but the vehicle accelerated away at a high rate of speed. Eventually, the vehicle yielded, and the officers began a DUI investigation. At approximately 2:30 AM, officers conducted a traffic stop and began an investigation. The driver was subsequently arrested for an active arrest warrant.
